IQF raspberries are processed from properly ripened fruit, which is selected, disinfected, individually frozen, inspected, packaged, and stored.

Food Safety Requirements

Product is prepared under strict sanitary conditions in accordance with Good Manufacturing Practices (GMP) and according to FSMA regulations, including compliance with EPA pesticide residue and cold-chain transportation. No additives are used in production, and final product should be free from allergens and GMOs.

Defects	Practically free from defects with the following tolerances per 16 oz: up to 1/8 square inch of extraneous vegetable material (EVM), one stem (none over ½" in length), 5% clumps, 2% agglomerates, 3% underdeveloped or immature, and 5% damaged berries.
Character	Good character with up to 20%, by weight, crushed, broken, or crumbles.
Flavor & Odor	Characteristic raspberry flavor and aroma and free of any undesirable odor or flavor.
